A regular bi-monthly meeting of the Board of Commissioners was held at Station #81 Headquarters in the Training Room, 463 W Main Street, Taylors, South Carolina at 4:30 pm.

The meeting was called to order by Chairman Hannah at 4:31 pm.

Chairman Hannah stated that the media outlets who requested notification of this bi-monthly meeting were notified via door posting, email, website, Facebook, and X.

Chairman Hannah led everyone in saying the Pledge of Allegiance.

Chairman Hannah introduced Mr. Brad Dill and Mr. Hank Hill with the Bonds Career Center. Mr. Dill briefed the Board on the Bonds Career Center and requested to partner with the Department for work based learning/internships with firefighting students at the Bonds Career Center. A brief question and answer session ensued between Mr. Dill and the Board. Vice Chairman/Treasurer Carter made a motion to allow the Department to participate in the Bonds Career Center internship and to designate Taylors Administrative Staff to execute all necessary documents and implementation. Secretary Bowen seconded the motion. The motion carried unanimously. Mr. Dill and Mr. Hill thanked the Board for their time.

Secretary Bowen made a motion to enter executive session as per SC Code of Law sections 30-4-70(a)(1) and 30-4-70(a)(2) for discussion of employment, appointment, position requirements, compensation, and promotion of a Fire Chief; for discussion of compensation and benefits of employees and Commissioners, and other employment related issues; and for possible discussion of negotiations incident to proposed contractual arrangements related to the proposed sale of property located at 3335 Wade Hampton Boulevard, Taylors, SC. Vice Chairman/Treasurer Carter seconded the motion. The motion carried unanimously. The Board entered executive session at 4:49 pm.

Secretary Bowen made a motion to exit executive session. Chairman Hannah seconded the motion. The motion carried unanimously. The Board exited executive session at 6:30 pm. No action was taken during executive session.

Chairman Hannah presented the minutes from the regularly scheduled bi-monthly meeting held on March 11, 2025 at 4:30 pm, the special called meeting held on April 3, 2025 at 10:00 am, and the special called meeting held on April 8, 2025 at 1:00 pm. Secretary Bowen made a motion to accept the minutes as written. Chairman Hannah seconded the motion. The motion carried unanimously.

Chairman Hannah asked Fire Chief Baker if there was anything pertinent in the Fire Department Reports. Fire Chief Baker stated that he had one thing, and presented the Greenville County Automatic & Mutual Aid Agreement and requested the Board's approval and signatures. With there being no further business with the Fire Department Reports, Secretary Bowen made a motion to accept the Greenville County Automatic & Mutual Aid Agreement as presented and the Fire Department Reports as written. Chairman Hannah seconded the motion. The motion carried unanimously.

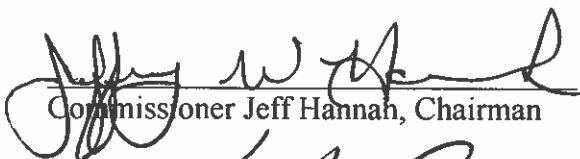
